Market Street, Greensboro, N.C., 27401 Attn: Jury.** A list of counties in the Middle District is provided below. <http://www.ncmd.uscourts.gov> valid proof consists of a valid driver license, passport, or other state or federal photo identification which includes your current address. Utility bills, pay stubs, lease or rental agreements are **not** considered valid proof of permanent residence.

The Middle District of North Carolina is made up of the following counties: Alamance, Cabarrus, Caswell, Chatham, Davidson, Davie, Durham, Forsyth, Guilford, Hoke, Lee, Montgomery, Moore, Orange, Person, Randolph, Richmond, Rockingham, Rowan, Scotland, Stanly, Stokes, Surry, and Yadkin.

Criminal Convictions - you must provide a copy of your judgment, or any other official court documentation, if you have been convicted of a crime punishable by imprisonment for more than one (1) year. Send this documentation with an explanation of your request in a letter or on this form with your summons or questionnaire immediately to: **U.S. District Court, 324 W. Market Street, Greensboro, N.C., 27401 Attn: Jury.**
