#### ORDER

On February 17, 2016, this Court, on behalf of the judges of the Middle District of North Carolina, entered an Order of Appointment directing the appointment of the Office of the Federal Public Defender for the Middle District of North Carolina in all cases in which the defendant (1) had been sentenced by application of 18 U.S.C. § 924(e) and (2) was potentially affected by the decision of the Supreme Court of the United States in Johnson v. United States, U.S. , 135 S. Ct. 2551 (2015). Since the entry of that Order, a number of new claims have been raised under Johnson that do not involve the application of 18 U.S.C. § 924(e). These claims are numerous, resulting in the filing of over 200 petitions pursuant to 28 U.S.C. § 2255 in June 2016 alone. As a result of the number of cases filed, the judges of this district find it necessary to create an orderly procedure for the prompt disposition of these cases.

In the Middle District, there are presently approximately 500 cases that raise claims related to <u>Johnson</u>. These claims have been reviewed and generally fall within the following six categories:

Category 1: Those claims resulting from the application of 18 U.S.C. § 924(e) at sentencing and addressed by the February 17, 2016 Order of Appointment. Counsel has been appointed in the majority of these cases and these cases will continue to proceed in accordance with the February 17, 2016 Order. The cases in which these claims are raised are identified in the attached Exhibit 1.

Category 2: Those claims resulting from the application of the Career Offender guidelines at sentencing and potentially affected by the analysis described in <u>Johnson</u>. The Supreme Court of the United States has granted certiorari in <u>Beckles v. United States</u>, No. 15-8544, 2016 WL 1029080 (U.S. June 27, 2016), to resolve whether the analysis in <u>Johnson</u> applies to the Career Offender guidelines. The cases in which these claims are raised are identified in the attached Exhibit 2.

Category 3: Those claims resulting from application of an adjustment under U.S.S.G. § 2K2.1 at sentencing or a similar guideline. Although no case presently pending before the Supreme

Court of the United States will definitively resolve that issue, it is likely the Supreme Court's decision in <a href="Beckles">Beckles</a> and, should the Supreme Court choose to grant certiorari, the decision in <a href="Dimaya v. Lynch">Dimaya v. Lynch</a>, 803 F.3d 1110 (9th Cir. 2015), <a href="petition for cert.filed">petition for cert. filed</a> (U.S. June 10, 2016 (No. 15-1498)), may provide substantial guidance as to the questions presented in these claims. The cases in which these claims are raised are identified in the attached Exhibit 3.

Category 4: Those cases which raise claims relating to <u>Johnson</u>, have been preliminarily screened by this court, and appear subject to dismissal for different reasons, i.e., filed as a second or successive petition without prior approval from the Fourth Circuit. The cases in which these claims are raised are identified in the attached Exhibit 4.

Category 5: Those claims arising from a conviction under 18 U.S.C. § 924(c) in which the underlying offense was a crime of violence. The cases in which these claims are raised are identified in the attached Exhibit 5.

Category 6: Those cases which raise an issue or claim under <u>Johnson</u> but do not fall into one of the categories listed above. These cases are identified in the attached Exhibit 6.

This court notes that petitions raising <u>Johnson</u> claims continue to be filed in the Middle District. As a result, the attached exhibits may be updated from time to time either by this Court or upon request by a defendant or counsel. Any such requests shall be referred to the Chief Judge by the Clerk.

In order to provide for the orderly administration of justice, this Court finds that appointment of counsel in each of the cases identified in Exhibits 2-6 is appropriate and, further, that an order staying each of the cases identified in the second and third categories (Exhibits 2 and 3) pending decisions by the Supreme Court of the United States should be considered. All of the cases identified in the attached Exhibits 2-6 will be stayed for a period of forty-five days from the date of this Order to permit review by appointed counsel and the United States. Thereafter, in the cases identified in Exhibits 4, 5, and 6, the stay will terminate and those cases will proceed through the relevant process for final determination of the issues, unless otherwise ordered by this Court or the assigned judge.

### I. Appointment of Counsel

Pursuant to the Criminal Justice Act, 18 U.S.C. § 3006A(a)(1) and (c), the Office of the Federal Public Defender

for the Middle District of North Carolina is hereby appointed to represent any defendant who was previously determined to have been entitled to appointment of counsel or who is now indigent, whose conviction is final, and whose case is identified in any of the attached Exhibits as potentially affected by the decision in Johnson or any related issue described herein. The purpose of this appointment is to determine whether these defendants may qualify for federal habeas relief under either 28 U.S.C. § 2255 or 28 U.S.C. § 2241, as described hereinabove, and for the limited purpose of providing general information to these defendants regarding the current legal issues arising from Johnson and the options for pursuing relief and for presenting any petitions, motions, or applications relating solely to these issues to this Court for disposition. This Order will be made applicable to each of the cases in the attached Exhibits and will constitute the order appointing counsel for the purpose of raising Johnson issues and related relief. If substitution of counsel is necessary in an individual case, the Office of the Federal Public Defender will determine the defendant's previous representation and will coordinate with the Clerk's Office to

submit a specific appointment of counsel for the Court's approval.

If the Office of Federal Public Defender or previously appointed counsel believes there is a conflict that would prevent the Federal Public Defender from assuming appointment for an individual defendant, counsel shall bring such conflict to the attention of the Court for adjudication of the issue or appointment of substitute counsel.

The United States Probation Office for the Middle District of North Carolina and the United States District Court Clerk's Office for the Middle District of North Carolina are authorized to disclose relevant Presentence Investigation Reports, Statements of Reasons, and Judgments to the Office of the Federal Public Defender for the purpose of determining eligibility for relief.

The Clerk shall promptly notify the Federal Public Defender of all pending <u>pro se</u> motions and petitions seeking relief in the cases described in this Order so that the Federal Public Defender can assume representation.

This Order shall be sufficient for the appointment of counsel, and the Clerk shall simply note the appointment of the Federal Public Defender by way of a docket entry in each of the

cases identified in the attached Exhibits. As part of these docket entries, the Clerk of Court will also note the entry of a forty-five-day stay, as described in Section II.A. of this Order.

# II. Stay of Cases Preliminarily and Pending Decisions of the Supreme Court

### A. Preliminary Stay upon Entry of this Order

Each of the cases identified in the attached Exhibits 2-6 will be stayed for a period of forty-five days from the date of this Order to permit review by the Federal Public Defender or other appointed counsel and the United States. In the cases identified in Exhibits 4-6, the stay will automatically terminate after forty-five days and these cases will proceed to resolution by the assigned judge unless an order is entered otherwise by this court or the assigned judge. If, after review, either counsel for the defendant or for the United States believes that some other action is necessary, a motion should be filed requesting relief before the stay terminates. A response to such a motion, if any, should be filed seven days thereafter and the matter will be resolved by the assigned judge or, if the

assigned judge is not available or a judge has not yet been assigned, by the Chief Judge.

#### B. Stay in Cases Pending a Decision in Beckles

As to the cases identified in the attached Exhibits 2 and 3, this Court is also considering, sua sponte, whether these cases should be further stayed pending the Supreme Court's decision in Beckles, and, should the Supreme Court choose to grant certiorari, its decision in Dimaya. It appears to this Court that it is likely that Beckles and Dimaya will either decide one or more relevant issues or provide significant guidance in deciding the relevant issues in the cases identified in the attached Exhibits 2 and 3. Accordingly, this Court gives notice of its intention, sua sponte, to stay each of the cases identified in Exhibits 2 and 3 and hold those cases in abeyance until such time as the Supreme Court of the United States issues its decision in Beckles. Upon issuance of the decision in Beckles, this stay will be lifted and those cases will be resolved. Also, following the decision in Beckles, this Court will determine whether to continue the stay in those cases

containing issued arising from the application of either U.S.S.G. § 2K2.1 or a similar guideline provision.

If either the United States or counsel for a defendant objects to the entry of a stay, a motion should be filed prior to the termination of the forty-five-day stay, noting the objection and explaining the grounds for that objection. A response shall be filed to any such objection within seven days and, if no response is filed, the Court will assume opposing counsel has no objection to the motion. After consideration of the written pleadings, the assigned judge will then decide whether to stay the case.

If no objection is filed by either party, this Court will enter a stay pending a decision in <a href="Beckles">Beckles</a> as described herein in each of the cases identified in Exhibits 2 and 3.

### III. Relationship of this Order to Other Orders or Procedures

In some of the cases identified in the attached Exhibits, counsel has been previously appointed or other issues exist, i.e., issues arising under <u>United States v. Simmons</u>, 649 F.3d 237 (4th Cir. 2011). In such cases, where the assigned court has already entered an order appointing counsel, staying the case, or directing briefing, the order specific to the case, entered

by the assigned judge, shall control and counsel should proceed in accordance with that order of the assigned court.

Similarly, after entry of this standing order, an assigned judge may nevertheless determine that a case should proceed as to certain individual issues and, if so determined, the parties should proceed in accordance with the orders of the assigned judge.
